4. Chair's report

We also enjoyed a wonderful Christmas in the school and church. Our Christmas hampers raffle was a success and we served mulled wine and mince pies at the school Christmas carol concert.

The children have enjoyed some amazing trips this year, which we have been able to support from our fund, from sporting events, the aquarium visit and a trip to a nuclear power station among others. I would like to say a huge thank you to everyone for making this happen, especially:

5. Treasurer’s report

We have continued to work with the volunteer fundraiser, Jill Bawden, on grant applications for projects with school. We propose setting up a separate bank account for grant money to be paid into and out of, to ensure it’s simpler to track and balance money for the specific grant funded projects.
